THE AUTH LIBRARY & INFORMATION CENTRE



The AUTh Library & Information Centre (AUTh Library) was founded in July 1927 and started operating in December of the same year. Currently, the Library and Information Centre is an independent decentralized unit of the Aristotle University of Thessaloniki, comprising the Central Library and its 45 branches.

The initial core of collection was formed by donations. Later, it was enriched by purchases and subscriptions. The collection includes manuscripts, books dating from the 15th century, maps, artifacts, etc. Currently the collection includes:

- More than 1.500.000 printed and electronic books
- 16.000 electronic journals (AUTh Library & HEAL-Link Consortium subscriptions)
- 36 bibliographic databases (AUTh Library & HEAL-Link Consortium subscriptions)
- More than 4.000.000 digitized pages from outof-copyright material (Psifiothiki digital library) and pages of papers, master theses and doctoral dissertations (IKEE



Institutional Repository)

The AUTh Library has successfully participated in three major operational programmes, co-funded by EU, in the last 20 years. Thanks to these funds, the Library re-organized its services. The University Library now offers traditional services, such as acquisitions and cataloguing, rare collections and digitization, loan and ILL services, reference. The Library's teaching support services include electronic coursepacks and library training. The research support services are electronic subscriptions, integration of search tools, scholarly communication services (IKEE Institutional Repository, Electronic Publishing) and support of the Hellenic Academic Libraries Consortium services (Electronic subscriptions, ERMS, NILDE, etc.).

The AUTh Library often displays its unique collections and promotes its services by organizing or participating in exhibitions and conferences. All collections and services are also promoted through the Library's social media accounts (Facebook, LinkedIn, Twitter, YouTube, and Instagram).

Some of the achievements of the AUTh Library are:

- the foundation of HEAL-Link consortium in 1998, the launch of the first digital library in Greece in 2002
- the partnership with the AUTh Quality Assurance Unit and the IT Center in 2013
- the 13th IFLA BibLibre International Marketing award for the "ThessWiki" crowdsourcing project in 2015
- cooperation with the AUTh Laboratory of Cartography and Geographical Analysis and 5 Museums of Thessaloniki in 2016 and
- the award of AUTh academic excellence in 2017.

Workshop between the Aristotle University of Thessaloniki and the Peoples' Friendship University (RUDN) of Moscow, October 3-5, 2018

In the frame of the Scientific Cooperation Agreement between the Aristotle University of Thessaloniki and the Peoples' Friendship University (RUDN) of Moscow, a workshop between the two Institutions took place on October 3-5, 2018. A twelve-member delegation visited the campus of the Aristotle University of Thessaloniki (AUTh). RUDN's delegation, headed by RUDN's Vice-Rector, Prof. Larisa Efremova and the Heads of the Agrarian and Technological Institute, the Institute of Medicine, the Academy of Engineering, the Institute of Mathematics and the Faculty of Humanities and Social Sciences, met with fellow colleagues from their respective Departments. Students and staff mobility, research opportunities and prospects of joint research and educational activity were thoroughly discussed during the Workshop. An ambitious joint two-year Master's Program in Organic Farming between the School of Agriculture of AUTh and the Agrarian and Technological Institute of RUDN has started in October 2018.







The "Interdisciplinary Centre for Aristotle Studies," A.U.Th. (DI.K.A.M.) was founded by the Senate of Aristotle University of Thessaloniki on July 6, 2011, as an act of acknowledgment of the close bond that connects it with Aristotle, as well as an act of acknowledgment of the enormous impact of the Macedonian philosopher on the human thought for twenty-four centuries. What makes this Centre unique, is both the fact that it is the only interdisciplinary Centre in the world for the study of Aristotle and that it is located a breath's distance away from ancient Stageira, the place where Aristotle was born in 384 BC, and ancient Mieza, the place where Aristotle taught Alexander the Great.

The primary purpose of DI.K.A.M. is to study and promote on a global scale, Aristotle's work in a range of topics covering all major fields of philosophy, such as Logic, Metaphysics, Politics, Ethics, Poetics, Rhetoric, etc., as well as the main disciplines of science, such as Physics, Biology, Medicine, Astronomy, Meteorology, Mathematics, Mechanics, etc. One of its goals is also to create programs for undergraduate and graduate students for the study of Aristotle.

Some of the activities of DI.K.A.M. thus far are the following: Organizing of International Conferences & Colloquia, Cultural Promenades in the Footsteps of Aristotle and Alexander the Great, Lectures on Aristotle for the General Public in Greece and abroad, participation in International Conferences, editing of volumes on Aristotle and Conference Proceedings. Recently, the top events of DIKAM have been: (a) The organizing of the World Congress "Aristotle 2400 Years," 23-29 May 2016, at the Aristotle University of Thessaloniki, in ancient Stagira and in ancient Mieza. The Congress hosted the impressive number of 250 contributed papers from 43 countries all over the world, 22 leading Aristotle scholars as invited speakers and 650 participants/attendees (b) the publication of the volume, Aristotle - Contemporary Perspectives on his Thought, edited by the President of the "Interdisciplinary Centre for Aristotle Studies," Demetra Sfendoni-Mentzou, and published by the prestigious German scholarly Publisher De Gruyter (https://www. degruyter.com/view/product/495383). The volume includes

20 essays of the invited speakers of the World Congress. The Proceedings of the World Congress "Aristotle 2400 Years," with 118 essays of the Parallel Sessions will appear within 2018 (Publisher: Aristotle University of Thessaloniki). DI.K.A.M. is also planning to organize a Summer School on Aristotle in collaboration with the University of Beijing-China, in ancient Stagira, primarily for Chinese students, but also for students from other countries.

The "Interdisciplinary Centre for Aristotle Studies," A.U.Th. (DI.K.A.M.) has already established, and is open to proposals for, collaborations with other Universities and Research Centres in Greece and abroad.

PROF. JEFFREY SACHS HONORARY DOCTORATE

"For me it is a paradox, how we can be so rich, and at the same time so foolish that we do not make basic steps that could save millions of lives." With these words and

while referring to Aristotle's economic theory, American Professor Jeffrev Sachs. one of the world's leading economists and experts on sustainable development and poverty reduction, has received an Honorary Doctor by the School of Economic Sciences of the Faculty of Economics and Political Science of the Aristotle University of Thessaloniki, granted by the Rector of the Institution, Prof. Pericles A. Mitkas.

Over the past two decades,

the insight and intelligence of Jeffrey Sachs have helped many nations in their struggles for stability, leading the New York Times Magazine to call Sachs "probably the most important economist in the world." He has served as a special adviser to the last three Secretary Generals of the United Nations, Antonio Guterres, Ban Ki-Moon and Kofi Annan. He has also worked with Pope John Paul II and served as an economic advisor to former Russian President

Boris Yeltsin, as well as to the governments of Bolivia, Poland and many more. He has twice been named among Time magazine's 100 most influential world leaders. A survey by The Economist in 2011 ranked Professor Sachs as amongst the world's three most influential living economists of the first decade of the 21st century.

An additional paradox of the modern economy is according to Prof. Sachs the fact that while complex and sophisticated energy systems based on renewable sources

of energy have been developed,

people still insist on forms of energy destroying the planet, explaining that the most complex challenge humanity facing nowadays is sustainable development.

Being a very enthusiastic supporter of the values of the work of Aristotle, Jeffrey Sachs always refers to Aristotle in his speeches and his writings, quotes his messages and even adapted Aristotle's philosophies to current practices. During his speech under the title "Why We Need a New Aristotelian"

Economics", he referred - among others - to addiction, noting that Aristotle had identified addiction as a sign that someone has exceeded his limits: "Addiction can destroy lives, and today people spend a huge part of their time trying to overcome their addictions. Addiction is today the largest industry in the US. What Aristotle did not predict is that modern economy would invent industries that live on addiction."



ESTABLISHMENT OF SDSN BLACK SEA

The identification of companions on the just started journey to address the issues of sustainable development in the wider Black Sea region is the priority of the newly established Sustainable Development Solutions Network (SDSN) Black Sea, the launching event of which was held on October 25, in Thessaloniki, in the presence of the head of SDSN Global, Professor at Columbia University, Jeffrey Sachs, and the Rector of the Aristoitle University of Thessaloniki (AUTh), Prof. Pericles A. Mitkas. The newly established SDSN Black Sea node will be hosted AUTh.

Prof. Sachs praised the tremendous importance of the establishment of the SDSN Black Sea Chapter, since—as he pointed out—the Black Sea region constitutes a very vulnerable ecosystem, which at the same time has to confront with challenges such as economic transformation and youth unemployment.

Nicolaos Theodossiou, Professor of Water Resources Management at the School of Civil Engineering, was appointed as chair of SDSN Black Sea Chapter. Prof. Theodossiou set as first goal to get in touch with the 110 Universities, from 12 different countries in the Black Sea region, to inform them of the new project that is already supported by Rectors of Universities within the region and to take advantage of the enormous potential that needs to be activated.

The Rector of AUTh and President of the Black Sea Universities Network (BSUN), Prof. Pericles A. Mitkas stressed that "AUTh will lead the effort. The network will consist of representatives of 12 Black Sea region countries and will aim to monitor the course of the countries and advise governments to reach the 17 UN goals faster" and noted: "The fact that Prof. Sachs is present in today's launch of the SDSN Black Sea Chapter, shows the world's confidence to AUTh. Our University has the expertise and know-how to actively get involved in such an educational networking initiative in an area that is vital to Greece in various fields".

"The Aristotle University of Thessaloniki is proud because a node of the SDSN in the areas of the Black Sea is starting today", said the Rector of AUTh. "We are trying to give the people of our countries the opportunity to contribute to this global effort, for the planet to proceed in a different way, and for humanity to deal with the very important problems of poverty or uneven development".

presentation, The titled "Artificial Intelligence: Evolution and Revolution (and Hype!)" of Prof. Dr. Yaser S. Abu-Mostafa, who was granted various awards with his scientific studies on artificial intelligence in California Institute of Technology (CalTech), attracted great deal of attention.

In his presentation, Prof. Dr. Yaser S. Abu-Mostafa explained the diagram of artificial intelligence using key words such as vogue words, terminology, quality, progress, conversion, difficulties. data inconsistencies. He opened his speech by expressing historical development of artificial intelligence and machine learning and relation between

them. Prof. Dr. Abu-Mostafa underlined that intelligence tried to carry out complicated tasks, learned new skills, and performed the functions such as innovation, undertaking and revolt. Prof. Dr. Yaser S. Abu-Mostafa continued his speech by drawing attention to vogue words and concepts such as artificial intelligence, learning with artificial intelligence, big data, deep learning, neural network, data science,

pattern recognition and data mining. He explained artificial intelligence and machine learning with examples. Prof. Dr. Abu-Mostafa, who told machine learning upon the process of a client's getting credit, conveyed that machine learning was a key technology in Big Data and various financial, medical, commercial and scientific application. Prof. Dr. Yaser S. Abu-Mostafa stated that with machine learning, it was possible to keep past records of the client and it was very easy to detect if a client was good or bad. He added that at this point algorithm

of learning would be able to form the borders depending upon data. Prof. Dr. Yaser S. Abu-Mostafa reminded the words of Stephen Hawking "The development of full artificial intelligence could spell the end of the human race." by laying emphasis of effects of artificial intelligence and machine learning on the society and economy. Prof. Dr. Yaser S. Abu-Mostafa said "Be careful for what you wish" by underlying that one day wishes would come true.



PROF. DR. DAN MCKEZNIE OF CAMBRIDGE WORLD-RENOWNED EARTH SCIENTIST

İstanbul Technical University continues to host world-renowned scientists and bring them together with $\dot{I}T\ddot{U}$ students and researchers.

Cambridge University Professor Dan McKenzie, one of the most prominent earth scientists who achieved many significant success and awards, met with scholars and students within the framework of İstanbul Technical University (İTÜ) Eurasian Earth Sciences Institute.

The seminar took place at İTÜ Faculty of Mines İhsan Ketin Conference Hall, with the attendance of large number of scholars, besides Prof. Dr. Celal Şengör of Faculty of Mines. In his speech, Prof. Dr. Celal Şengör was quoted "Undoubtedly, today, Dan McKenzie is the greatest earth scientist alive. He is a dear companion of our university for a long time. He has become a bridge between many İTÜ scholars and Cambridge. He is a fantastic person and we are very happy to host him at our University."

In his speech, Prof. Dr. McKenzie gave significant information about volcanism and mantle convection in the Middle East and Central Africa. Dan McKenzie, who has been researching on Turkey's tectonics since 1987, emphasized that earth's crust moving and data flow is more calculable compared to the past. Prof. McKeznie, who almost pictures the earth movements in the Middle East and Africa with his research, drawed great interest of İTÜ scholars and students with his remarkable presentation.

Who is Dan McKenzie?

McKenzie, who owns Crafoord Prize which is deemed to be the Nobel Prize of Earth Sciences, succeeded numerous significant research regarding the emergence of plate formations constituting the earth, comparative movements of the plates and the reasons behind such movements. McKenzie developed a stretching model, which is being used by all petroleum companies in petrol research studies and he is recognized as one of the founders of plate tectonics theory, which has a revolutionary impact in Earth Sciences. McKenzie, who has spent his whole academic life at Cambridge, conducted his doctoral studies with famous physicist Sir Edward C. Bullard and he still continues his research at Bullard Laboratories in Cambridge. McKenzie, who was awarded by the Order of the Companions of Honour by Queen Elisabeth II, contributed at a great extent to Turkey's geology with his remarkable studies.

The "BeeTalks Science and Technology Summit Dialogues" 2nd meeting at Istanbul Technical University (İTÜ) 2018-2019 Academic year was carried out on October 2nd, 2018 at the Süleyman Demirel Cultural Center during. Prof. Dr Aydoğan Özcan, known globally for his work in Science, Engineering and Medicine, was the guest of our university. "Deep Learning" technology was discussed at the meeting, with the attendance of our Rector, Prof. Mehmet Karaca, the Principal Advisor for the President of the Turkish Republic, Prof. Davut Kavranoğlu, and many academicians and students. Prof. Mehmet Karaca referred to scholar Özcan with praise and as "our country's honor" during his opening speech and thanked him for his lecture.

Nano Technologies inclusive of Artificial Intelligance in the field of Health

Prof. Özcan presented a general overview of the subject

by exemplifying with studies carried out within the scope of "Deep Learning". Özcan, who referred to "Deep Learning" and its various fields of use and the opportunities it presents, presented and exemplified information on modern dayfuture intelligent screening in the field of medicine and detection and diagnosis systems. Accordingly, he shared his experiences of how medical services could be offered more productively. Dr. Özcan indicated how he felt great honor of being at İTÜ and mentioned new technologies in the field of telemedicine and global health, and their fields of application. Some of these technologies were given as: "Lens Free Holographic Microscope and Mobile Phone Fluorescent Microscope", "LUCAS (Lens Free Ultra-wide-field Cell Monitoring Array Platform based on Shadow Imaging)", "LUCAS Holographic Microscope", "LUCAS with High Resolution" and "Establishing E-Coli Bacteria with Mobile Phone". Additionally, he also mentioned that the field of application includes the detection of maintenance, diagnosis and disease observation points, blood count, sperm count and waterborne parasites.

At the end of the lecture, Dr. Özcan answered questions and



had one to one talks with students.

What is Deep Learning?

Its name comes from the deep neural networks general structure, which is formed by various artificial neuron layers materializing from a transaction which is planked on one another and is non-linear. It offers many pioneering

opportunities in the fields of composing images beyond main stream applications such as the recognition of specific features in images and labelling in various images, reconstruction and perception.

Prof. Dr. Aydoğan Özcan

Aydoğan Özcan, born in 1978 started showing interest in science and mathematics at secondary school. After graduating from University in 2000 he went onto complete his Master's degree at Stanford University in 2002, and Doctorate degree in 2005. He then continued his studies for a period of two years at Harvard University and during this time started showing interest in areas of electronics and medical issues. Aydoğan Özcan, who started his academic post at the University of California carried out studies in optic technologies and its use in diagnosing diseases.

NKU CENTER OF CHOICE FOR CANDIDATES

Following the Higher Education Institutions Exam (YKS), which is a long and exhausting test marathon, a large number of candidates preferred the undergraduate and associate degree programs of our university as a result and joined Namık Kemal University family in Tekirdağ.

After the announcement of the results of the Higher Education Institutions Exam (YKS), Tekirdağ Namık Kemal University became an attractive center of preference for many students.

According to the results of YKS 2018, our university was chosen by 5 thousand 245 new students. In 2017-2018 academic year, NKU with the number of 35 thousand 95 students will reach around 36 thousand in 2018-2019 academic year.

According to the results of the ÖSYS, the number of candidates who had the right to enroll in a program in NKU has been announced recently. The number of students settling in undergraduate programs is 2 thousand 302, while the number of students settling in associate degree programs is 2 thousand 943, and the number of students in doctoral programs has increased to 293, while the number of students settling in master's programs has increased to 2 thousand 396. 4 thousand 673 students settled in the first education while 572 students preferred to study in secondary education at our university.

Faculty of Fine Arts, Design and Architecture, Faculty of Theology, Faculty of Medicine and Faculty of Veterinary Medicine have reached 100% occupancy rate. Faculty of Arts and Sciences followed them with 98% and Faculty of Economics and Administrative Sciences and Corlu Engineering Faculty with %85 and with 63% Agricultural Faculty followed.

Çerkezköy Vocational High School and Health Services Vocational School have reached a rate of 100 percent.

On the other hand, School of Health has also reached 100% occupancy rate.

Prof. Dr. OsmanŞimşek stated thatTekirdağ Namık Kemal University's strong academic staff with international experience, technical infrastructure adapting to the requirements of the era that can be continuously developed, providing abroad experiences as well as creating a bright future for our nation's young people by offering high-quality facilities. "Economic development as a precondition for EU integration" and "The Rule of Law and Civil Society" were the topics of two international scientific conferences, which held the proceedings at the University of Tetova.

Scientific researches from the fields of economy, business, tourism, administration etc, at the 6th international conference organized by the Faculty of Economics and Faculty of Business Administration presented their papers on economic development in our country, the growth of foreign trade and investment as well as on the benefits that our country will have with the membership in Euro-Atlantic structures. While scientific researchers from the fields of justice, media, civil society, etc, at the 5th international conference, organized by the Faculty of Law of the University

to deal with various issues. "I believe that the editorial boards of the respective conferences, with the selection of these current topics, will debate scientifically all the issues facing the rule of law today and the alternatives of accelerating the strengthening of the economy. Referring to the first topic, we consider that an important role in encouraging institutions respecting and enforcing laws, realizing their commitments, further deepening of institutional reforms that promote participation and cooperation, belongs to the civil society. But this happens in the states with a functional democracy, where civil rights and civil society are respected to participate in decision-making processes, access to public information, the right to propose laws, the right to freedom of speech and many other rights guaranteed by the constitution. Despite



of Tetova in cooperation with "Iustinianus Primus" Faculty of Law of Ss. Cyril and Methodius University, discussed about reforms in the justice system, the role of media and civil society.

Rector of the University of Tetova, Prof. Dr. Vullnet Ameti, at the opening of conferences' proceedings, said that the topics dealt with in these conferences are very current as we all are witnessing the great developments that take place in our country, endless debates in relation to emerging events, public expectations for the future of the country and its orientation towards progressive aspirations. According to him, universities, as the most representative institutions of society, certainly cannot remain indifferent in these situations, all the more that they have the professional competence, the proper preparation, the necessary cadres and the clear vision

the abovementioned lack of standards, in our country and not only civil society has contributed to the advancement of many processes, both in the service delivery sector, mobilization of local communities, protection of groups in need, transparency of institutions and strengthening of their capacities" – said Prof. Dr. Vullnet Ameti.

He further added that the international community calls for deep reforms, especially in the field of justice, which would have direct effects over other relevant sectors as well, including the civil society. "Regarding the economic development, rules are also required to ensure that economic competition is achieved in equal conditions, within a competitive system worthy of a democratic society. Our country and our neighbors in the Western Balkans region are oriented towards Euro-Atlantic integration, but to embrace





the European values, the consolidated democracy, and the rule of law, we must all engage strongly, give our contribution as a civil society, as educational institutions, and as a progressive society of the 21st century" - said among others the UT Rector, Prof. Dr. Vullnet Ameti.

The Minister for Foreign Investments of the Government of the Republic of Macedonia, Prof. Dr. Bardhyl Dauti, said that Macedonia's most viable option and fairer determination remains the integration into the European Union and NATO. "Euro - Atlantic integrations are a strategic objective of the Republic of Macedonia as a guarantee for security, peace, stability and development. Integration into the EU means a larger market, greater competition, more opportunities, and greater security for all citizens. For countries like Macedonia, the question shouldn't be whether to integrate into the EU and NATO, but how to accelerate this process"- said Minister Prof. Dr. Bardhyl Dauti.



The President of the Economic Chamber of Northwestern Macedonia highlighted particularly the Global Competitiveness Index report, which was published a few days ago by the World Economic Forum, and which states that the current state in the sphere of the economy but also in other areas is not favorable in the Republic of Macedonia. "Another fact of concern about this report is that country's institutions are ranked in the 85th place, which is an indication that business is struggling because of institutional stagnation. Therefore, we as a Chamber of Commerce, consider that, in order to achieve our goals as a country and as a business sector, policy makers should also undertake concrete initiatives for the development and progress of the state to reach the level of the EU member states." - stated Mr. Nebi Hoxha.

Assessments on the importance and topics of the sessions of these conferences were also given by the Dean of the Faculty of Law, Prof. Dr. Qebir Avziu, dean of the Faculty of Economics, Prof. Dr. Raman Ismaili, and the Dean of the Faculty of Business Administration, Prof. Dr. Naser Rahimi. man's life round up such a synthesis as Professor Topalli had. Such a great experience and research life will miss our science for a long time"- said Prof. Dr. Berton Sulejmani.

While Prof. Dr. Anila Omari from the Center of Albanological Studies in Tirana stated that the "Etymological Dictionary of Albanian Language" by Professor Kolec Topalli is his last major work, which crowned the experience of a life devoted to scientific research in the field of Albanian language and its history. "Professor Kolec begin his study of the history of Albanian language in the 70s and the first results of this work were published in the only scientific journal of the Institute of Linguistics "Philological Studies" - said Prof. Dr. Anila Omari.

While Prof. Dr. Begzat Baliu from the University of Prishtina emphasized that the etymological dictionary of the Albanian language of Professor Kolec remains one of the largest syntheses and one of the deepest synthetic corpuses of Albanian language. "The work of Professor Kolec Topalli comes as a continuation of the tradition of etymological studies of the Albanian language, which methodologically and conceptually, constitutes in itself the best achievements not only of its internal developments, but of the European school in general as well"- said Prof. Dr. Begzat Baliu.

In this activity, the director of the Institute of Linguistics and Literature in Tirana, Prof. Dr. Valter Memishaj bestowed the book "Etymological Dictionary of the Albanian Language" by the academic author Kolec Topalli to the Rector of the University of Tetova, Prof. Dr. Vullnet Ameti.



The members of the Moot Court of the 'Universitas' Club of the Faculty of Law of the University of Tuzla at this prestigious competition have won the second place and, at the same time, they are the best ranked law faculty in the area of Bosnia and Herzegovina. Participation in this competition was preceded by intensive preparations for solving a complex hypothetical case based primarily on the protection of rights guaranteed by the European Convention on Human Rights and Fundamental Freedoms.

the countries of the region took place before the judges' councils, composed of judges of the highest court instances from countries of the region and the world, such as: Boštajn M.
